## 1 Introduction

The participation fee is 100 € and it covers:

- Accommodation (3 nights)
- Meals
- Local Transportation (Train/Bus)

The participant must cover his own transportation to and from Paris, France. We advise to come by plane at Charles de Gaulle International Airport or Orly International Airport. But there are also many train stations : Gare de Lyon, Gare du Nord, Gare de l'Est ou Gare Montparnasse.

Note: Please, do not go to Beauvais Airport. It is 1h30 by car from Paris so, it would be difficult for us to come pick you up.

## 2 Deadlines

First round of applications starts from the 10<sup>th</sup> of April to the 24<sup>th</sup> of April.

In this 1st round of application participants will be accepted in the following way:

- First 2 International Board members;
- 2 Trainers selected by the International Board;
- 1 International Events WG Tutor;
- First 2 members from each AS/PAS/PPAS, in first-come first-served order.

After that the second round of application starts the 25<sup>th</sup> of April to the 9<sup>th</sup> of May. During the second round of application everyone has the right of one week (seven days) for his free cancellation, after that period the default rule is applied.

At this moment, the limit of participants is 20. Places that become available before the end of the second round of applications due to cancellation are assigned to applicants on the waiting list.

All the participants on the Waiting List that applied between this dates are automatically moved to the Participant List (in accordance with the number of free places).

After the first round of applications the preliminary participant list will be published by EUROAVIA Paris at <http://euroavia.epf.fr>



All participants must pay his participation fee of 100€ (see section 3 for more information) before the 1st of May.

In case of a cancellation, EUROAVIA Paris has the right to keep the following amount of the participation fee according to the date of cancelation.

**4<sup>th</sup> of May:** after this date, EUROAVIA Paris keeps 75% of the participation fee. So applicant must pay 25% of the participation fee (25€).

**18<sup>th</sup> of May:** after this date, EUROAVIA Paris keeps 50% of the participation fee. So, applicant must pay 50% of the participation fee (50€).

**1<sup>st</sup> of June:** after this date, EUROAVIA Paris keeps the whole fee. So, applicant must pay the whole fee (100€).

Please, note that EUROAVIA Paris has to booked accommodation, transportation tickets, some activities and meals before your arrivals. This is the reason why, it is allowed to keep a part the whole participation fee in case of a cancellation.

**We will accept applications until the 14<sup>th</sup> of May.**

### 3 Payment rules

EUROAVIA Paris will send the payment information to the confirmed applicants. We will accept bank transfers and Payment via PayPal.

All the taxes should be covered by the applicant, so EUROAVIA Paris will receive the total amount of 100€.

We will not accept cash payments, except from people who are not in the SEPA agreement. In this case, we authorized maximum 2 cash payments.

After confirmation of the participants AS become responsible for the insurance that the participation fee will be paid in case the participant refuses to paid.
